### FREIGHT INSURANCE

"In many cases, your freight shipment might have a higher value than what is covered under the carrier's liability. Carrier coverage typically sets a small dollar amount payable per lb, based on what they believe those goods are valued at. Typically, even after proving they are at fault, we have seen truckers pay as low as 10 cents per lb; which is nothing near the value of any damaged freight. This is where freight insurance comes in handy."

# LOW SULPHUR – FUEL RECOVERY (LSR)

In an effort to reduce marine pollution and decrease the maritime industries ecological footprint, the International Maritime Origination (IMO) has instituted the "IMO 2020 regulation" to reduce the amount of pollutants released into our oceans from ocean vessels. This regulation states that as of January 1<sup>st</sup>, 2020, the highest permissible Sulphur content of vessel fuel will be 0.5 percent as opposed to the current 3.5%. Certain zones along the coast of North America, Canada, and Europe have an even lower maximum Sulphur content of 0.1%.

Along with the regulation comes a surcharge which varies per line depending on that shipping line's method of reducing their vessel Sulphur production. Method's to reduce sulfur content range from using lower sulfur content fuels or implementing technology that filter the Sulphur from current fuels. The surcharge arises because regardless of the method, costs to invent and implement new, compliant fuels or filtering methods will inevitably arise and passed along to the consumers.

While IMO surcharges for FCL containers will vary per shipping line, our LCL surcharge will be as follows:

### • Min: \$8.00 | Rate: \$8.00 w/m

# K-9 AIRFREIGHT CARGO SCREENING

Earlier this year, the U.S Department of Homeland Security's Transportation Security Administration (TSA) has approved a new method of screening cargo that can solve some major problems and delays. Canine screening has shown to be much more accurate and swifter in comparison to screening machine procedures (x-ray, CTX, explosive trace) that are currently in use. The canines can screen cargo, tendered by forwarders that is already built-up on airline pallets, from the outside without having to break them down to screen at the piece by piece level and rebuild them.

K-9 screening is expected to drastically reduce acceptance time at cargo facilities, leading to faster processing of freight at cargo terminals and reduced truck lines and detention at major airports. Atlanta (ATL), Chicago O'Hare (ORD), Los Angeles (LAX) and New York Kennedy (JFK) have the most to gain due to their current issues with trucker wait lines which can regularly exceed 3-4 hours to drop cargo; causing missed lockouts. As this new method of screening takes place, with a growing number of private canine screening firms being approved, we can hope to see improved airline turnaround with less delayed flights.
